### Did You Know? - Part 3

Here are more rules & regulations that we all might have forgotten about over the years.

1. No outdoor laundering, drying lines or other apparatus for the drying of clothes, bathing suits, towels, etc. will be permitted on any space, nor shall any such items be left draped or hung in yards, carports, Florida or screen rooms, if visible from street. (Guilty! I have a small drying rack for my wet towels, which I will no longer be using.)
2. No appliance shall be located in or around a mobile home so as to become a noise nuisance to adjoining mobile homes or installed and/or located in an unsightly manner. Compressors for central air conditioners shall be installed in accordance with appropriate governmental ordinances. No window-type air conditioning units are permitted in the park.
3. All garbage, trash, grass cuttings, leaves and the like must be placed in plastic receptacles and kept in a concealed place. (Guilty again! I’ve often left my recycling bin in my front yard for easy access.)
4. Each mobile home household is entitled to a maximum of two vehicles, which must be parked in its driveway. Parking on the grass is prohibited at all times, and street parking will only be allowed for deliveries and pickups.
5. All trailers, motorhomes, campers, boats and other large-size equipment or accessories belonging to a resident must be kept in their compound area, if one is available, or outside of the park if

6. Each resident must maintain radio, record players, televisions, voices and other sounds at a moderate level, particularly between the hours of 10:00 P.M. and 9:00 A.M. (Oops! I thought quiet time only started at 11pm. Sorry neighbors!)

### **GOOD DRIVERS, BAD DRIVERS, & SO-SO DRIVERS**

Everyone complains at times about some of the bad drivers in Florida, but I have news for you – there are some places that are consistently much worse. For example, when I first moved from Michigan to Carolina Beach, NC in 2007 my auto insurance rate almost doubled, so I called Geico to find out why this was. Their response was I moved to a **high risk** area where there were numerous accidents daily and hundreds of claims.

Florida drivers can be bad at times but over-all my personal experience on the road here is very favorable. Some examples of BAD drivers/driving habits I've encountered are the following:

Not using their turn signal to inform the driver in front or behind that you are about to make a turn.

No, you don't need your turn signal when you are at a stop sign, or a light, and the sign says, "Right Turn Only."

Remember the song, 'Hokey Pokey', well Florida has lots of these kinds of drivers and it's not always senior's. Here's a hint! When driving in the left lane whether on the freeway or Hwy 41 and if you notice numerous cars passing you on the right then that is a huge clue you may not be driving fast enough, unless your driving slow on purpose and plan to turn left somewhere close up the road. Move to the middle lane, pokey!

I'm not suggesting you speed but you need to observe the flow of traffic as well as remain cautious to your surroundings. The invention of the mirror was for a specific reason.

When driving through the Publix or Winn Dixie parking area you should always observe the safety cross walk areas and remain alert. If someone is walking across that path very slowly stay still and be patient. Do not inch your car forward. They may think you don't plan to stop, especially when sitting at a stop light in the right turn lane even though you have the right to turn right on a red light. Inching your car forward speaks to oncoming traffic that it may be iffy if you plan to lunge into or in front of oncoming traffic like I've seen numerous times. Be patient. Wait for traffic to clear! What's the hurry?

One of my pet peeves is when folks pull past the thick white line at a stop light. The reason for the thick white line is for drivers to be aware of where to stop their vehicle. Too often folks pull up past the thick white line which could prove to be

dangerous.

Running or turning on a red light is a no-no, unless of course you're waiting for traffic to come to a complete stop before making a left when the light turns red. Its okay, you can turn on the red if you're sitting in the middle of the intersection.

For example, when turning left and you see the light turning yellow and the car in front of you completes their left turn – then, it's time to stop. Too often you see one or two cars complete their left turn after the light turns red. What's the hurry? Are you an accident waiting to happen or are you just tempting the traffic gods?

When turning left onto Colonia Ln (in front of Captain Eddie's) from Hwy 41 oftentimes visibility is obstructed by the car sitting in the opposite left lane because they were stupid enough to pull their vehicle into the intersection and sit there at an angle, blocking your view on oncoming traffic. Remember the old adage, "It's better to be safe than sorry." Wait and make sure it is clear for you to turn left. Don't be in such a hurry. You'll get there.

Many times we take Albee Farm Rd to turn left at Hwy 41 in order to travel south. There are 2 left turn lanes, the middle lane to cross 41 with and the right turn lane. I've seen numerous cars turn left from the middle lane and the right lane. If you screw up and find yourself in the wrong lane you can always continue your path then make a Uey. Don't be rude. Sort of like being on I-75 and you may be driving in the middle lane then all of a sudden the car in the left lane, who didn't want to miss their exit but almost did, dashes across the highway to make their exit at the last second. Don't drive silly to the point where you may jeopardize traffic and maybe causing ab accident. Use your signal and move over to the middle or the right lane and take the next exit. Better to be safe than sorry, don't ya think!

Simple stuff – nothing complex.

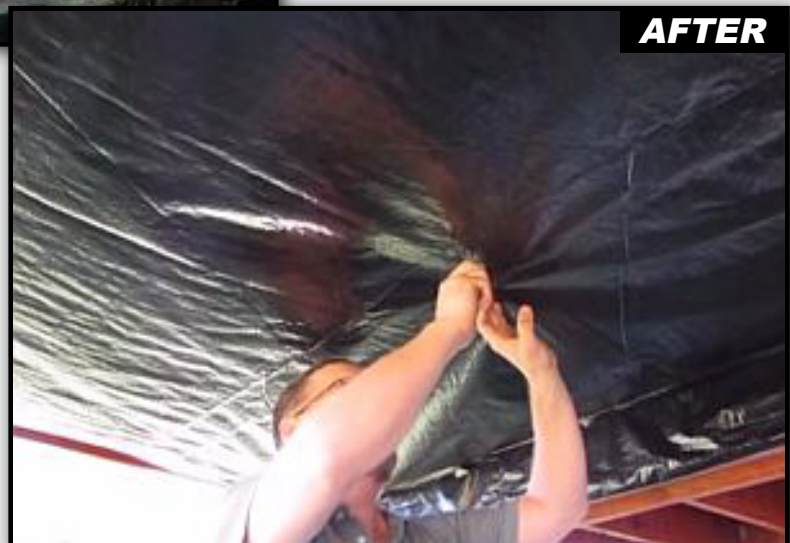

## **CHANGES ARE COMING TO GARBAGE COLLECTION SERVICES**

Automated garbage collection service is coming to unincorporated Sarasota County in March 2025. This process is used by waste haulers to more efficiently and safely collect materials for disposal by using mechanical arms to empty the contents from the containers.

Each residence will receive one garbage cart, with the option to select a 95-gallon, 65-gallon or 35-gallon cart. This is included as part of the annual non-ad valorem tax assessment collected through the property owner's tax bill. Property owners and residents will be able to request additional garbage carts. The additional carts will be considered a supplemental service so residents will be billed directly by their hauler for collection and disposal services. More information about additional carts will be provided closer to the service transition.

### **Key Dates**

Nov. 11-Dec. 31, 2024: Select preferred size for new garbage cart\*.

January-March 2025: Delivery of new garbage carts.

March 31, 2025: Automated garbage collection service begins with new franchise haulers.

### **New franchise haulers**

Waste Pro of Florida, Inc. was selected as the new franchise hauler for the Solid Waste North Service Area and FCC Environmental Services of Florida, LLC was selected as the new franchise hauler for the Solid Waste South Service Area.

Continue to follow current disposal guidelines for collection services through March 28, 2025. For additional details about the upcoming changes including FAQs and maps of service areas, please visit [scgov.net/FreshStartWithACart](http://scgov.net/FreshStartWithACart).

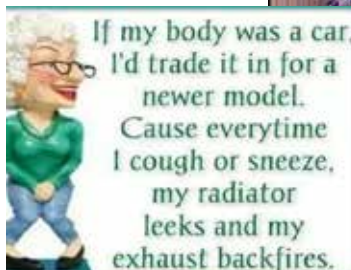

Jimmy founded the Save The Manatees Club, now sporting over 40,000 members working together to fund research, rescue, conservation, and rehabilitation efforts.

His iconic song Margaritaville is considered the most lucrative song ever written. Restaurants, resorts, and casinos all over the world bear his name.

Jimmy Buffett had made his home in Key West for over 30 years, and passed away peacefully at his home in Sag Harbor, NY on September 1, 2023, after a four-year battle with Merkel Cell Skin Cancer. He was 76.

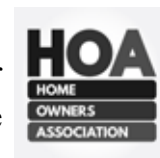
