#### Did You Know? - Part 4

*\*\*This article is for information purposes only and not intended to aim at any homeowner, resident, occupant or home.\*\**

Here are a couple more rules & regulations that we all might have forgotten about over the years:

1. All recreational facilities are used by residents and guests at their own risk.
2. Minor children or grandchildren of residents may visit four weeks out of any calendar year. Use of any facilities of the park by such minors shall be accompanied by an adult at all times.
3. No resident may engage in any type of commercial business in the park.
4. No garage, patio or rummage sales are permitted on any mobile home space. (Good thing we have our Annual Rummage Sale at the Clubhouse.)
5. Each resident must avoid walking on the lawns of other residents. (No shortcuts please.)
6. No one who does not have a valid driver’s license may drive any motorized vehicle in the park. (This includes golf carts.)
7. Except for household pets, in designated areas, no animal, livestock or poultry of any kind may be kept in, on or about any space in the park.

## In a Quiet House

Karen handles the reminder calls to our clients and finds it amusing when they answer and say, "I don't hear well, can you speak up?" It turns out they usually aren't wearing their hearing aids when they take the call, which is why they struggle to hear.

When she asks why they aren't wearing their hearing aids, the most common response is, "I'm in a quiet house." Karen understands their logic is I don't need to hear as much since the house is quiet.

However, hearing isn't just about the volume of sound, it is also about what sounds your brain notices.

If you've ever gotten a new fridge it seems to have the noisiest ice maker ever created. It isn't too loud, your brain is showing off by highlighting a new sound you weren't aware of. Over time you will stop hearing your ice maker. Your brain will learn to ignore it. The volume of the ice maker hasn't changed, your attention to that sound has diminished.

Similarly, when wearing your hearing aids consistently your brain will alert you to sounds that aren't common for you or to sounds you want to hear.

Hearing speech in noisy environments relies heavily on your ability to focus your attention. High-quality hearing aids that enhance speech in noise can give you an edge in crowded or noisy settings, such as restaurants. By consistently wearing your hearing aids, even in quiet situations, you train your brain to prioritize important sounds, like speech, and filter out background noise.

By wearing your hearing aids even in a quiet house, you can tell your brain what to ignore. Like all things, listening takes practice. In this case, just wearing your hearing aids in all environments gets you to hear your best. Also, when Karen calls with your appointment reminder you will hear her clearly.

### FAST FOOD WARS

Rather than place this lengthy article under the column, 'My Favorite Film or TV Show' I opted to create an editorial since there is much to say about the subject of fast food and how it came to be.



On Sunday, a few weeks before writing this article, The History Channel aired the following birth of several food items we still enjoy today. The 50's exploded with fast food chains, which spilled into the 60's as well. No question McDonalds was very popular when they first opened, simply because of the ingenuity of the new owner (he bought the name for pennies on the dollar) who created the first assembly line for cooking burgers. Fast and easy was the end result. The only problem with McDonalds, was in the early days, their French fries lacked consistency. They weren't consistent throughout the country because the source for their potatoes came from several farms. It didn't take long, though, for the new owner to select Russet potatoes from Idaho for all of the franchise restaurants and the consistent flavor and size of the fries was a critical aspect of those yummy fries we all enjoyed munching on along with a burger. I mean, you can't have a burger with fries.

Then the Filet O' Fish was born, sporting the very first fish-on-a-bun sandwich with that yummy tartar sauce I still enjoy once in a while whenever I get the craving.

America quickly fell in love with fast food and fast service back in the day. Then along came Burger King – Home of the Whopper, the first conveyor automated flame broiled burger and it became a huge success - the only rival of McDonalds at the time before the birth of several other burger joints entered the scene. TV ads created quite the stir in the Miami area. Why, you may be wondering? Because it takes two hands (they showed this on TV) to hold the Whopper. And this my friend is called guerilla 'marketing'. The Whopper became insanely popular. And it was loaded with tomatoes, lettuce, onions and pickles, ingredients that McDonalds didn't feel was important for their burgers. Their new name, Burger King, (the old name sucked) became an instant success with franchisee's. That is until 1967 when the Big Mac was born, created by a Mc Donalds franchisee - simply two regular size burgers sandwiched between 3 bun slices with a special topping and shredded lettuce. As such, the burger wars began and the Big Mac quickly killed Whoppers popularity, where it dropped into 2nd place in the burger wars.



Then along came an inventor who saw the need to create a taco from the same ground beef as the burger but with a touch of Mexican flavors. Tacos **were not** a popular fast food item simply because it was a Mexican dish, something America was not familiar with. But, thanks to Glenn Bell, the founder of Taco Bell, this fast-food Mexican dish took off like wild fire. The crunchy shells became a huge success, eating a burger on a crunchy shell in place of a soft bun. America was infatuated with fast food and this trend continued. Bell then added rice and beans to the menu, created his own taco sauce then eventually, over time, expanded the menu, adding a half dozen new items to the menu at that time. Today the Taco Bell menu offers a large variety of Mexican dishes. Mexican restaurants everywhere should be thankful for Taco Bell for bringing the flavors of Mexico to America.

Then along came Arby's. Two business partners saw the need to create a roast beef sandwich and their logo was, and is, the Big Cowboy hat. You see, American TV shows in the 50's and 60's sported a dozen, or more, TV Westerns and America quickly became hooked on the western culture. When Arby's first opened they were hard pressed to find franchisees who were interested in a roast beef sandwich. Burgers were the boss at that time. But, they soon changed the way America ate. It took a while but when they created the Arby's sauce (not a BBQ sauce) and the Horsey sauce these two items turned the roast beef sandwich around and made it gourmet dining – fresh sliced, warm and juicy roast beef on a bun. Then cheese was added later to top it off.



One doesn't think about the failures many of these early pioneers endured before becoming a success, or the debt they buried themselves in to get their business going, like Colonial Sanders who created the KFC brand of fried chicken who experienced bankruptcy several times before his famous chicken recipe hit a home run.

As they say in life, 'no pain, no gain'.

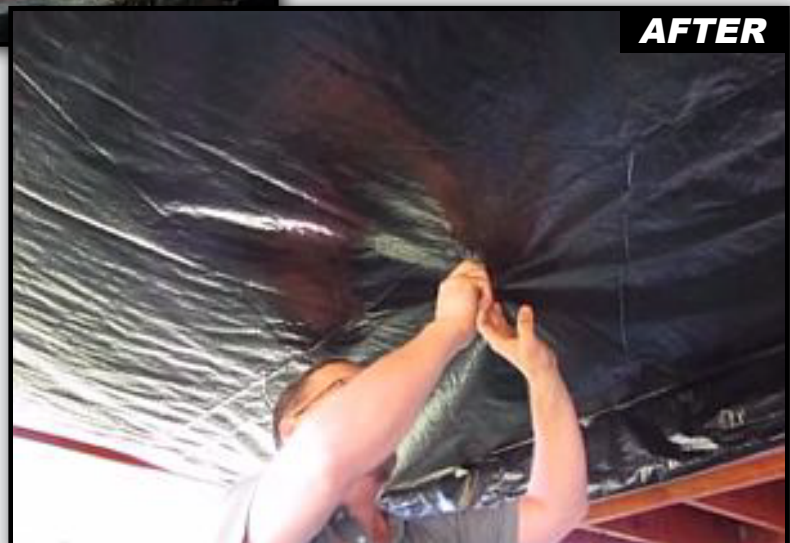

## CHANGES ARE COMING TO GARBAGE COLLECTION SERVICES

Automated garbage collection service is coming to unincorporated Sarasota County in March 2025. This process is used by waste haulers to more efficiently and safely collect materials for disposal by using mechanical arms to empty the contents from the containers.

Each residence will receive one garbage cart, with the option to select a 95-gallon, 65-gallon or 35-gallon cart. This is included as part of the annual non-ad valorem tax assessment collected through the property owner's tax bill. Property owners and residents will be able to request additional garbage carts. The additional carts will be considered a supplemental service so residents will be billed directly by their hauler for collection and disposal services. More information about additional carts will be provided closer to the service transition.

### Key Dates

Nov. 11-Dec. 31, 2024: Select preferred size for new garbage cart\*.

January-March 2025: Delivery of new garbage carts.

March 31, 2025: Automated garbage collection service begins with new franchise haulers.

### New franchise haulers

Waste Pro of Florida, Inc. was selected as the new franchise hauler for the Solid Waste North Service Area and FCC Environmental Services of Florida, LLC was selected as the new franchise hauler for the Solid Waste South Service Area.

Continue to follow current disposal guidelines for collection services through March 28, 2025. For additional details about the upcoming changes including FAQs and maps of service areas, please visit [scgov.net/FreshStartWithACart](http://scgov.net/FreshStartWithACart).

## THE HUMANE THING TO DO

On 08/18/2024, 60 minutes aired a special about a doctor in Kuznov, Ukraine, who stayed behind following an attack in order to take care of those who were injured during the bombings. He set up the basement of a partially collapsed building or hospital to perform his work and housed the injured. There were rows of beds in the basement and he did what he could, equipment wise, to help those who needed medical attention. He said during his interview that he saved more lives than lost lives. All the other doctors fled after the bombing except for him. When asked why he stayed behind his only comment was, "who else was going to help my people."

During the same show they showed how powerful PEDAL MINES were that Russia had planted before fleeing a war zone area in Ukraine. The pedal mine is about 5 inches long yet packed a powerful punch. A group of Ukraine volunteers stepped forward and created teams to hunt and peck for these deadly

mines. One young female deminer in particular was asked why she risked her own life to locate these vicious mines and her reply was "I wanted to save other people from dying. This is my contribution to victory".

The pedal mines were labelled as a brilliant yet very evil invention. This relentless hope from Ukrainians who chose to help and save others is most definitely "The Humane Thing To Do."
